Truckee-Donner Recreation & Park District hereby grants Truckee Sunrise Rotary (hereinafter called the "Licensee") represented by Jeff Sparksworthy, if approved, permission to use the Facilities as outlined, subject to the Terms and Conditions of this Agreement contained herein and attached hereto all of which form part of this Agreement.

The submittal of this application does not insure its approval. Approval may usually be confirmed within one week of submittal. These facilities must be clean and vacated by the end of your rental time, or in the case of West End Beach, by dusk. All fees are due at time of application. Deposit checks are not held. Fees received within one month of rental must be in cash or by credit card. Fifty percent (50%) of the rental fee will be retained if event is cancelled more than 4 weeks prior to date of event. If cancelled less than 4 weeks before event, the entire fee is forfeit. There are no refunds due to inclement weather except West End Beach, in which case if the beach is closed all day due to weather, fees will be returned, less administration fee. District personnel will determine the condition of the facility after your group's departure, and that decision will be final. If additional staff time is required to return the facility to an acceptable state, an additional charge will be made of \$20 per man hour and the total sum deducted from your cleaning/damage deposit. Failure to comply with policies and procedures as described herein may result in revocation of this agreement and/or forfeiture of your deposit. Deposit refunds are processed automatically, and take 3-4 weeks to be returned to you. Credit card deposits will be returned to the credit card.
